EARNEST MONEY DEPOSIT

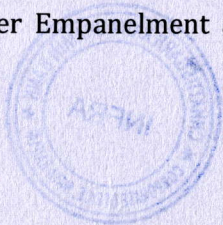
The vendor shall deposit EMD of Rs 50000.00 (Rs. Fifty Thousand only) in the form of a valid demand draft **in favour of 'Chhattisgarh Rajya Gramin Bank', payable at Raipur.** No interest will be payable on the Bid security amount. The EMD will be forfeited if the vendor withdraws its Bid during Bid validity period. Refuses to honour commercial bid. Bank reserves the right to place order on to vendor based on prices quoted by them. Refuses to accept Purchase Order for disposal of E-waste issued by any of the branch/office of, fails to carry out his obligations mentioned therein with the stipulated time. EMD of unsuccessful vendors will be returned after completion of bid process.

EMD Security of successful vendor will be released, without interest, after successful completion of agreement (Based on the service provided).

Bidders with NSIC certification, MSE and startups will be exempted from RFP fees. Bidder has to submit necessary proof of document.

Para 09. Clarifications as

All Bidder/Vendor with NISC Certification, MSME Certificate holder and MSE Startups will be exempted from RFP fees of Rs. 1000.00 (Rs. One Thousand Only) at initial process of empanelment. But after Empanelment all Empaneled Vendor has to deposit EMD of Rs.



50,000 (Rs. Fifty Thousand Only) in the form of a valid demand draft in favour of "Chhattisgarh Rajya Gramin Bank" Payable at Raipur. No interest will be paid on EMD amount.

ELIGIBILITY CRITERIA SL NO. 07

The Bidder should have a full-fledged office in Chhattisgarh and should have arrangements to provide e-waste recycling services in Chhattisgarh.

Para 05 Eligibility Criteria Sl no. 07 amended as

No office required in Chhattisgarh but vendor have to submit the proof of office address as (Registration Certification, Gumasta and rent agreement etc.) However local preference will be given to Chhattisgarh based vendor/bidder.

Sub Para 18.2 Commercial Bids

- d) Commercial bids of only technical qualified shortlisted bidders will be opened.
- e) Bank's evaluation of the commercial bids will take into account the status of compliance of terms and conditions.
- f) The Sale value including all costs (without taxes) for each item need to be quoted as per Annexure-IV format, In case sale value not quoted for any item, the bids will be rejected.

Sub Para 18.2 Commercial Bids amended as

The vendor/bidder does not need to submit the commercial bid (Annexure-IV) initially because the bank will first empanel the vendors. After empanelment, the financial proposals will be invited from the empaneled vendors.
